Czech language and Czech Life and Institutions Exam

DEMONSTRATING KNOWLEDGE OF THE CZECH LANGUAGE AND CZECH REALITIES IS ONE OF THE CONDITIONS FOR OBTAINING CZECH CITIZENSHIP.

You must register for the exam in person or online (<http://ujop.cuni.cz/obcanstvi>). In the application form, you indicate your preferences (e.g., exam location), and after opening of the specific dates, the system will automatically assign you to available slots according to your preferences. Czech language:

You can register for both parts of the exam (Czech Life and Institutions and Czech language) on the same day, or you can take each part of the exam separately (two different dates). The Czech language exam can now be divided into two days, with the written part taking place on the first day and the oral part on the second day.



Both tests are subject to a fee:

Exam from Czech language and exam from Czech realities	5 700 CZK
Exam from Czech language only	3 700 CZK
Exam from Czech realities only	2 000 CZK

After completing the online application, you will receive an email with your billing information. The fee must be paid within 7 days of submitting your application.

ATTENTION! Proof of payment of the exam fee must be brought with you on the day of the exam (it can also be a receipt from online banking or a bank statement). A valid internationally recognised travel document (passport) and proof of permanent residence are also required.

Participants who fail the exam may re-register for the exam (or part of it – only for the Czech Life and Institutions or Czech language sections) and pay the exam fee again.

- In the case of the Czech language exam, all parts are repeated.
- **The number of repetitions is not limited.**

CITIZENSHIP

Czech language and Czech Life and Institutions Exam

THE CZECH LANGUAGE EXAM consists of a written and an oral part.

1. The written part of the exam tests skills:

- reading comprehension (50 minutes),
- listening comprehension (30 - 35 minutes),
- writing (60 minutes).

The participant writes all answers with an ordinary pencil on the record sheet and can erase incorrect answers with an eraser. A sample record sheet can be found in the [model version of the Czech language exam \(B1\)](#).



A pass mark requires an overall score of at least 60%, including in the individual parts of the exam, and only 50% is possible in one of the written parts. If a candidate fails any part of the examination, he/she must repeat the whole examination.

2. The oral part of the exam tests speaking skills (in pairs for 15-18 minutes).

EXAM OF CZECH LIFE AND INSTITUTIONS (=CZECH REALITIES) includes knowledge of the constitutional system of the Czech Republic, basic orientation in cultural, social, geographical and historical realities of the Czech Republic.

The examination in Czech realities is held in written form (test). It contains a total of 30 test problems (30 minutes, choice of 4 options, the test is for 30 points - 18 points are required for success).

- 16 questions of civic foundation - everyday life, citizen, state and law, citizen and money, work and business,
- 7 basic geographical information - Czech Republic in socio-economic and socio-cultural context, Czech Republic in international context,
- 7 basic historical and cultural information - 20th century and present, important personalities, art.
