

# OBLIGATIONS OF FOREIGNERS FROM THIRD COUNTRIES IN THE CZECH REPUBLIC

An important obligation of foreigners from third countries is to report their presence on the territory of the Czech Republic within 3 days.

In case you change your place of residence in the territory - change of address, it is necessary to report this change ideally at the OAMP office of the Ministry of the Interior of the Czech Republic or send it by mail or data box:

- within 30 working days if:
  - o you have a long-stay visa or long-term residence permit and the change of residence will be for more than 30 days.
  - o you have a permanent residence permit and the change of residence will be longer than 180 days (in this case, you must not forget to pay the administrative fee of CZK 1,000, CZK 500 for persons under 15 years of age and exchange the biometric card).
- within 15 days if:
  - o you have a long-stay visa for seasonal employment (report the change to the relevant police department)
- within 3 working days if:
  - o you have been granted temporary protection.

OTHER CHANGES THAT NEED TO BE REPORTED	BY WHEN THESE CHANGES MUST BE REPORTED
First name/surname	Within 3 working days
Status (marriage, divorce, widowhood)	Within 3 working days
Travel document/ID card details (including replacement)	Within 3 working days
Details in the document (e.g. in the residence card)	Within 3 working days
Loss, destruction, damage or theft of an identification document (also report to the police)	Within 3 working days

*The changes are reported at:*

- *the immigration police if you have a visa-free stay or short-term visa.*
- *OAMP office of the Ministry of the Interior of the Czech Republic if you have a long-term visa, long-term or permanent residence.*

## Obligation to complete the Adaptation and Integration Course:

Selected groups of foreigners who have been issued a long-term or permanent residence permit in the Czech Republic since 1 January 2021 must complete an Adaptation and Integration Course within 1 year of receiving their residence permit.

## Duties of the legal representative:

- apply within 60 working days for the newborn child to be issued with the same residence permit as his/her own (only in the case of a long-term visa, long-term or permanent residence permit)
  - o Apply even if you don't have your child's travel document yet!
- Ensure that all obligations towards persons under 15 years of age are met, including legal residence (after the age of 15 years, it is up to the person to take care of all matters).
